AbstrArt 4, like its previous editions, will bring your abstract works to popular online bookstores, such as Amazon, Apple Books, Google Play Books, Kobo Books, Mondadori, and others that will enter distribution in the weeks following publication. It's an art ebook catalog in English language, professionally created and distributed, which, thanks to its complete distribution, will showcase your art to an international audience. The volume will be released in the online bookstores mentioned above between the end of November and the beginning of December.

Art.1 - AbstrArt Vol.4 offers each artist the opportunity to participate in two types of publication:

Opzione 1: Includes 5 works by the artist, with a biography and a personal photo, distributed over 5 pages.

Opzione 2: Includes 9 works by the artist, with a biography and a personal photo, distributed over 7 pages.

- ✓ We will promote the e-book volume on our website, through our social media channels, on art websites and networks via press releases and advertising
- ✓ **Participation includes a virtual exhibition** set up in the metaverse/virtual world of Second Life, which will be livestreamed on our YouTube channel at a later date following the publication of the volume. All information will be provided to participants via email.
- ✓ All participating artists will receive an artistic merit certificate via email acknowledging their selection and participation in the volume. The certificate will be sent in a printable digital format.

Art.2 - WHO CAN PARTICIPATE:

- The call is open to all artists of any nationality aged 18 years and above.
- Permitted artistic categories: all
- Excluded from selection are works promoting hatred, racism, sexual or vulgar content, as well as works with religious or political themes and those that may be discriminatory based on gender.

Art.4 - HOW TO PARTICIPATE IN THE SELECTIONS / DEADLINE:

Deadline for submissions: November 10, 2024

The first selection phase is free of charge.

At our email artbook@makeartgallery.com you will need to send:

1. **Five or nine artworks**, as specified in the options in Article 1 of this regulation. High-resolution and non-blurry images are required (submitting more artworks increases the chances of being selected)
2. **For each artwork**, please provide the title, the technique used, the dimensions, and the contact information you wish to include in this volume.

3. **Your biography** in English (maximum 1300 characters including spaces). If you are unable to write it in English, it will be translated directly by our staff. To count the number of characters including spaces, you can also use the free website <https://wordcount.com>

The selection of candidate artworks will be made at the unquestionable discretion of the members of an artistic jury and the Make Art Gallery committee.

The artist will receive a participation confirmation email only if selected. The official list of participants will be published on our website, and we will communicate it through our social media profiles (Instagram, Facebook, Twitter, Threads, Mastodon).

Art.5 - PARTICIPATION FEE:

After receiving confirmation of selection and a welcome email, the artist will have the opportunity to confirm their participation by paying a participation fee via Paypal or Stripe.

The artist can choose between two options:

- Fee Euro 20 (includes 5 artworks, biography, and a personal photo, distributed over 5 pages)
- Fee Euro 30 (includes 9 artworks, biography, and a personal photo, distributed over 7 pages)

The selected artist can choose the type of fee based on their publication preferences.

It's important to remember that only selected artists will receive the participation confirmation email at the end of the selection period.

Payment deadline: The fee payment is required within 3 days of confirmation.

In case of delays, please contact us to arrange a new date.

Failure to communicate will result in cancellation of participation.

AbstrArt vol.4 will be available for free to the public who wish to read it in online bookstores. However, on Amazon, a download price may be applied, which may vary depending on the country. Nevertheless, we always encourage readers to download the volume for free from the other listed bookstores.

Art.6 – POLICY PRIVACY:

With the sending of the selection email, you confirm that you have read all the clauses of the call. The personal data provided will be processed according to the European Regulation for the Protection of Personal Data GDPR. Your data will only be used for communications, updates, tax purposes, and the relevant artistic application, ensuring that they will not be disclosed to third parties.
